Discontinue PG part numbers shown in the table. Historically, PG designated parts were "lead-free and halogen-free" while PN part numbers were "lead-free" only. For many years, Power Integrations have been using the same bills of material that are both "lead-free and halogen-free" for both postfixes. The devices, regardless of the marking, are identical and completely interchangeable, differing only in the laser mark. This discontinuation notice is issued for the less popular marking products to assist supply chain management.

REASON FOR DISCONTINUANCE:

Consolidation of the low volume PG ordering part numbers to PN ordering part numbers.

ALTERNATE PARTS:

The replacement products are guaranteed to meet the same datasheet limits and the replacement parts are pin compatible.
