1 General description

The 74ALVCH16825 is an 18-bit non-inverting buffer/driver with 3-state outputs for bus-oriented applications.

The 74ALVCH16825 consists of two 9-bit sections with separate output enable signals. For either 9-bit buffer section, the two output enable ($1\overline{OE}1$ and $1\overline{OE}2$ or $2\overline{OE}1$ and $2\overline{OE}2$) inputs must both be LOW for corresponding nYn outputs to be active. If either output enable input is HIGH, the outputs of that 9-buffer section are in the high impedance state.

The 74ALVCH16825 has active bus hold circuitry which is provided to hold unused or floating data inputs at a valid logic level. This feature eliminates the need for external pull-up or pull-down resistors.




Figure 1. Logic symbol

Figure 2. IEC logic symbol




Figure 3. Logic diagram




Figure 4. Bus hold circuit




Figure 5. Pin configuration SOT364-1 (TSSOP56)





Figure 6. Input nAn to output nYn propagation delays





Figure 8. Test circuit for measuring switching times


