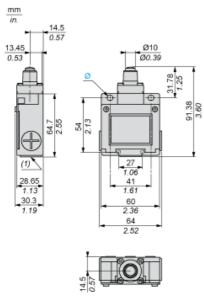

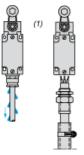

Position of Cable Gland

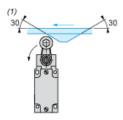
