Allegro currently manufactures the A1391, A1392, A1393 and A1395 devices on a 6" line at PSL wafer FAB in Bloomington, MN.

What is the part or process changing to (provide details)?

Allegro has transferred the semiconductor wafer fabrication process used to manufacture the A139x devices to an 8" wafer line at UMC in Taiwan, primarily as a capacity enhancement and security of supply initiative. The fabrication process at UMC uses the same BiCMOS technology used to manufacture the A139x devices at PSL today.

This is a technology transfer only to UMC FAB and there is no anticipated impact to fit, form or function of the IC. The schematic diagram and the layout of the devices are identical at both PSL and UMC. No design changes were made during the process transfer.

There is no expected impact on the fit, form, or function of the device and should have little to no influence on customer applications.
