



Equivalent Circuit
















V_{GS}, GATE-SOURCE VOLTAGE (V) Figure 2 Typical Transfer Characteristics




Figure 4 Typical Drain-Source On-Resistance vs. Gate-Source Voltage







Figure 6 On-Resistance Variation with Temperature

















Figure 8 Gate Threshold Variation vs. Junction Temperature












