2. CHINA-RoHS II Compliance Declaration

The part that ESPROS Photonics AG has identified as China RoHS II compliant have a maximum concentration of 0.1% by weight in homogenous materials for lead (Pb), hex chrome (Cr6+), mercury (Hg), PBB, PBDE, and 0.01% for cadmium (Cd).
